## 2016 EVENTS.... SEAMAMMS 2016

Over the first weekend of April, The <u>Southeast And Mid-Atlantic Marine Mammal Symposium</u> was held in Savannah—(for the first time)– and co-hosted by Savannah State University and The Dolphin Project. SEAMAMMS is an annual event that is held at various locations from Virginia to Florida, typically at Universities or marine mammal labs at government agencies such as NOAA. In Virginia it was held at the Virginia Aquarium. SEAMAMMS is an opportunity for marine science students, from undergrad to PhD, to present their research studies. Noted marine science experts can offer advice. Often these noted experts present their research



projects as well. The Studies can be in oral or poster form.

SEAMAMMS has been an enormous resource for TDP to enhance the training and educational outreach programs through our connections and collaborations with marine science experts from the Smithsonian down to Texas. Most of the presentations are about the SE coastal marine mammals. However some of these marine



## Obama bans offshore drilling... Washington Post

On December 20<sup>th</sup>, President Obama withdrew hundreds of millions of acres of federally owned land in the Arctic and Atlantic Ocean from new offshore oil and gas drilling. He used a little-known law called

the Outer Continental Shelf Lands Act to protect large portions of the Chukchi and Beaufort seas in the Arctic and a string of canyons in the Atlantic stretching from Massachusetts to Virginia. In addition to a five-year moratorium already in Atlantic, place in the removing the canyons from drilling puts much of the eastern seaboard off limits to oil exploration even if companies develop plans to operate around them.


The announcement by the White House late in the afternoon was coordinated with similar steps being taken by Canadian Prime Minister Justin Trudeau to

shield large areas of that nation's Arctic waters from drilling. Neither measure affects leases already held by oil and gas companies and drilling activity in state waters. "These actions, and Canada's parallel actions, protect a sensitive and unique ecosystem that is unlike any other region on earth," the White House said in a statement. "They reflect the scientific assessment that, even with the high safety standards that both our countries have put in place, the risks of an oil spill in this region are significant and our ability to clean up from a spill in the region's harsh conditions is limited. White House officials described their actions to make the areas off limits to future oil and gas exploration and drilling as indefinite. Officials said the withdrawals under Section 12-A of the 1953 act used by presidents dating to Dwight Eisenhower cannot be undone by an incoming president. It is not clear if Congress can rescind Obama's action.

> "There is a precedent of more than half a century of this authority being utilized by presidents of both parties." a White House aide said. "There is no authority for subsequent presidents to un-withdraw. . .. I can't speak to what a future Congress will do." "The U.S. is not acting alone today. Canada is acting to put an indefinite stop to activity in its waters as well," the aide said. "With Canada, we send a powerful signal and reinforce our commitment to work together."

David Rivkin, an attorney for the Baker and Hostetler law firm who served on the White House Counsel staffs

of Ronald Reagan and George H.W. Bush, disagreed with the assertion that the decision cannot be overturned. "Basically I say the power to withdraw entails the power to un-withdraw," Rivkin said, "especially if you determine the justification for the original withdrawal is no longer valid." A legal fight would likely follow, Rivkin said. But "it's not clear why Congress would want to give a president tremendous authority operating only one way." Sen. Ted Cruz (R-Tex.) responded sharply on Twitter: "Yet another Obama abuse of power. Hopefully, on [e] that will be reversed...exactly one month from today" after Trump's inauguration. Cruz closed his

tweet with a hashtag: "Taking away Obama's pen and phone."


U.S. and Canadian officials have negotiated for months to reach a joint understanding on how to manage adjacent areas in the ocean in an effort to make the new protections as sweeping and politically durable as possible. Meanwhile, advocacy groups lobbied Obama to ban oil and gas leasing in the Arctic entirely. Obama already invoked the Outer Continental Shelf Lands Act to safeguard Alaska's Bristol Bay in 2014, and again last year to protect part of Alaska's Arctic coast. The president has protected 125 million acres in the region in the last two years, according to a fact sheet issued by the White House.

The Beaufort and Chukchi seas are habitat for several species listed as endangered and species that are candidates for the endangered species, including the bowhead whale, fin whale, Pacific walrus and polar bear. Concern for the animals has heightened as the Arctic warms faster than anywhere else in the world and sea ice the bears use to hunt continues to melt.

The underwater canyons protected by the president cover nearly 4 million acres across the Atlantic continental shelf break, "running from Heezen Canyon offshore New England to Norfolk Canyon offshore the Chesapeake Bay," according to a separate fact sheet. They are widely recognized as major biodiversity hotspots that are critical to fisheries. The canyons provide deep water corals used by a wide array of fish. The area also provides habitat "for ... deepwater corals, deep diving beaked whales, commercially valuable fishes, and

significant numbers of habitat-forming soft and hard corals, sponges, and crabs," the White House said.

The American Petroleum Institute denounced the decision. "The administration's decision to remove key Arctic and Atlantic offshore areas from future consideration ignores congressional leasing intent, our national security, and vital, good-paying job opportunities for our shipyards, unions, and businesses of all types across the country," said Erik Milito, the group's Upstream director. "Our national security depends on our ability to produce oil and natural gas here in the United States," Milito said. "This proposal would take us in the wrong direction just as we have become world leader in production and refining of oil and natural gas and in reduction of carbon emissions." Contradicting the White House's statement, Milito said George W. Bush removed previous 12-A withdrawal areas with a memorandum and made all but marine sanctuaries available for leasing. "We are hopeful the incoming administration will reverse this decision as the nation continues to need a robust

strategy for developing offshore and onshore energy," he said.



But a wide range of conservation groups hailed the Voters decision. League of Conservation President Gene Karpinski called it "an incredible holiday gift," saying that "an oil spill in these pristine waters would be devastating to the wildlife and people who live in the region." Rhea Suh, president of the Natural Resources Defense Council, called it "a historic victory in our fight to save our Arctic Atlantic waters. marine and life. coastal communities and all they support." Carter Roberts, president and chief executive of the World Wildlife Fund, applauded what he called "a bold decision" that "signals some places are just too important not to protect." Oil production in the Arctic represents a tenth of one percent of the nation's oil production overall, the White House said. The area is so sensitive and so remote that the economics of exploration is costly.

Shell, which said in September 2015 that it would shelve drilling plans after spending \$7 billion and not finding significant amounts of oil, still has one remaining lease in the Chukchi Sea where it drilled a well earlier last year. Shell is also part of a joint venture with Italian oil giant ENI and Spanish firm Repsol in the Beaufort Sea that holds 13 leases. Shell held other leases in the Beaufort Sea, which the company transferred to the Arctic Slope Regional Corp., a company belonging to the Native Americans in the region.

An earlier plan to allow limited drilling off the Atlantic coast was shelved after state governments along the southern Atlantic coasts — including Virginia, North Carolina, South Carolina and Georgia — expressed worries over the effect on their beaches, tourist industry and environmentally sensitive marsh.

The Navy also objected. The Pentagon provided Interior with a map "that identifies locations ... areas where the [Defense's] offshore readiness activities are not compatible, partially compatible or minimally impacted by oil and gas activities," department spokesman Matthew Allen said. The map included nearly the entire



proposed drilling area. Live training exercises are conducted off the Atlantic coast, "from unit level training to major joint service and fleet exercises," Allen said in a statement. "These live training events are fundamental to the ability of our airmen, sailors, and marines to attain and sustain the highest levels of military readiness."

The Obama administration eventually closed the Atlantic to drilling for five years.

Outgoing President Barack Obama used his executive authority to "permanently" ban oil drilling in parts of the Arctic and Atlantic oceans, but this move may be illegal, according to an industry group. Obama's administration used a legal strategy crafted by environmental activists to remove sections of the Arctic and Atlantic oceans from future offshore drilling lease sales, which they claim will be "permanent."

"It is pretty clear that this is a hollow 11th hour action," Christopher Guith, a senior vice president at the U.S. Chamber of Commerce, told The Daily Caller News Foundation. "In spite of the narrative that extreme interest groups who pushed the White House to do this, there's nothing about this that's permanent. The White House itself didn't use the phrase permanent, they said it was 'indefinite.""



The administration and its environmental allies used Section 12(a) of the Outer Continental Shelf Lands Act, a 1953 law governing offshore drilling, in an unprecedented way to block offshore drilling leases in the Atlantic Ocean and the Chukchi and Beaufort seas. "This flies in the face of how we do offshore leasing," Guith continued. "Every 5 years, we have to do a new offshore leasing plan. There's already precedent for a new President rescinding his predecessors withdrawal. George W. Bush rescinded Clinton's offshore drilling ruling already when gas prices were high."

Environmentalists hope it will take Trump or Congress years to repeal an Obama decision to permanently keep Arctic and Atlantic areas off limits to drilling, but a simple lawsuit could overturn all of that.

"I'd be very surprised if somebody like the State of Alaska or an industry group didn't sue President Obama immediately," Guith told TheDCNF." There are a lot of questions about whether Obama's ruling followed the law. By the time it

> gets to court, the Obama administration is now the Trump administration. That will be a huge policy difference."

> Offshore drilling in the Atlantic Ocean has the potential to produce 1.3 million barrels of oil and natural gas per day while generating nearly 280,000 jobs and contribute up to \$23.5 billion per year to the U.S. economy, according to a 2013 study by the <u>American Petroleum Institute</u>.

"The Trump administration could easily just agree with the plaintiff and rescind Obama's ruling," Guith concluded. "Despite all the vitriol of the people who

have been pushing this, this isn't really much of a legal question. Trump can unilaterally rescind this via executive order. Environmentalists would sue, but any first-year law student would tell them they'll almost certainly lose."

## Obama's offshore drilling plan could be illegal... The Daily Caller

The primary federal rulings blocking offshore drilling are studies from the Bureau of Ocean Energy Management in consultation with the Department of Defense, which state that drilling <u>could potentially</u> <u>interfere with naval operations</u>.

"This is ultimately a symbolic attempt," Guith noted. "There are steps they could have taken that would have been much more permanent. They didn't use those mechanisms because they know that if they had, it'd taint other much more robust laws."

Offshore oil drilling platforms and import facilities are too costly an investment when at its currently remarkably low prices. Major players like Exxon-Mobil have actually <u>lost money</u> in the U.S. offshore drilling business for six straight quarters, but if prices rise this could become the more attractive option.

Even Virginia Democratic Sen. Tim Kaine, Hillary Clinton's choice to become vice president agrees. Kaine joined legislators in sending a letter to the Department of the Interior in April 2015, pushing for expanded offshore drilling.

Opening federal lands for natural gas, oil, and other drilling would create 2.7 million jobs and add \$663 billion to the economy each year for the next 30

prohibition is unclear. TAKE NOTE: Obama's offshore drilling plan <u>does not prevent seismic</u> <u>testing.</u> We can't allow this to begin because it will be the beginning of the end of life here as we know it. We Georgians and South Carolinians need to be especially vigilant, write our president -elect. Write our legislators. Talking face-to-face is even better. Spread the word with friends and neighbors about protecting our coast...with the **FACTS.** (which have been stated in previous ON EFFORT newsletters) We have a treasure here. It's our responsibility to protect it now and in the future.

## An Open Letter to Buddy Carter by Roy "Hub" Hubbard

This letter was printed recently in local newspapers:

An open letter to Representative Buddy Carter

December 1, 2016

#### Dear Representative Carter,

On one of your recent visits to Richmond Hill I provided you with a DVD and some accompanying literature regarding the practice of seismic testing in ocean waters to detect oil deposits. There is a covert movement by big oil to bring seismic testing to the continental shelf on the Georgia coast.

I am hopeful that by now you have found the time to review the material provided. The DVD, entitled "The Sonic Sea" addresses the fact that the occupants of the ocean, the animal life, depend almost one hundred percent on sound and sound waves to survive.

Seismic testing destroys that ability. At the very least it bursts ear drums, drowns out animal sound waves better known as "echo location" used, among other things, to locate food, each other and natural enemies. Seismic testing seriously hampers, if not completely destroys, marine animals ability to navigate. Almost every aspect of marine animal life will be totally disrupted by the horrendous blast of seismic sound waves. The necessary actions of feeding, mating, protecting, defending, navigating, and just generally surviving will be greatly diminished to the point of expiration of some species.

Seismic sound waves are literally one hundred thousand times more powerful and louder than the blast of a jet engine. Seismic sound waves are capable of stripping flesh from the bone. Even the U.S. Government admits to estimates of hundreds of thousands of animals, sea life, being destroyed if the testing is done. Those estimates are low.

I have serious concerns after hearing rumors of Big Oil interests attempting to influence the Georgia vote with large campaign contributions when the subject of Seismic testing comes to the political table.

Presently, President O'Bama has declared a moratorium on drilling for oil off the Georgia coast. That is nothing more than political double talk.

There would most probably not be any attempt to do any drilling for at least the next four to five years. The seismic testing comes first.

Representative Carter, the documentary "Sonic Sea" which I provided you, addresses the horrendous negative effect seismic testing would have on marine life. Additionally, it is necessary to factor in the potential disastrous results to the coastal-connected businesses that represent a multi-billion dollar industry and more importantly, the quality of life for coastal residents. The question of wantonly destroying millions of animals for greed is immoral and unethical.

Seismic testing is the immediate threat simply because it paves the way for drilling for oil. That is the greater and final threat. The entire coast of Georgia is unique in the world where the dynamics of near shore movement of water are concerned. We are not the Gulf of Mexico. Oil slicks from ruptured oil wells in the Gulf are dependent on very slow currents and surface winds to move and spread them. That is not the case on the coast of Georgia.

Every twelve hours a phenomena occurs on the Georgia coast. We experience the highest tides south of Cape Cod. Every twelve hours we experience billions of tons of water flowing from the sea, at speeds of several knots per hour, running deep into our coastal estuaries and back

out again. We experience tides that are seven to ten feet, or more, on the Georgia coast when, in comparison, Charleston, South Carolina may have a two foot tide and Jacksonville, Florida experiences zero tides.

The Atlantic Bight is a curve in the Continental shelf with the entire coast of Georgia being located in the apex of that curve. That configuration creates a funneling effect, dumping billions of tons of water into our coastal marshlands twice a day in a massive rush. This is a phenomenon not experienced either to the north or south of our coastline, not in the Gulf of Mexico and certainly not on the plains of Texas!

Were there to be a ruptured oil well, which I would suggest is an inevitability, oil would literally encircle our barrier islands destroying all of those miles of beautiful pristine beaches and resident wild life. It would then fill our marshes, creeks and rivers. Were the disaster to occur during an Equinox tide or an extremely high tide, oil could top roads, settle in people's yards and wreak permanent havoc all the way past I 95.

Do the math. A ruptured oil well forty miles out to sea with oil traveling with the natural current at three to five knots would inundate the coast of Georgia within ten hours. You are not going to vacuum up oil in the Atlantic Ocean.

There is almost a continuous influence of north easterly winds and general flow of water from north to south along our coast. A ruptured oil well anywhere along the Carolina coast or northern portion of the coast of Georgia would affect the entire coast of Georgia.

Within another one to two hours the oil would have impacted our sounds, coated our marshes and

tributaries and continued up stream polluting our rivers for several miles. Then the tide would reverse. Much of the crude would permanently settle in place with another wave of destruction washing back out across our marshes and sounds towards the sea on the outgoing tide. All this destruction so somebody can sell more petroleum to Russia and China?! I don't think so.

It may sound preposterous but a ruptured oil well off the Georgia coast could literally permanently destroy the entire coastline with a coating of crude oil.

I know the battle cry of "energy independence" sounds great. I only question why the facts that we are actually reducing our demand for fossil fuels and the market for such fuels is moving to Europe and Asia are not both included in the discussion.

I would rather pay more for gas than allow the entire Georgia coast to become an un-occupiable oil slick. I vote NO to seismic testing and NO to oil wells in the Atlantic Ocean. My vote doesn't count. The vote of our representation does. Who represents me/us?

Representative Carter, in my humble opinion, your position on this matter should be made public to your constituency post haste. I hope your conclusions are simply that we cannot expose ourselves to the very real possibility of sacrificing so much for big oil profits. Your public stand against seismic testing and a promise of a "NO" vote from you and we can set aside those rumors of Big Oil influence in Georgia politics.


